The above named defendant is accused by the Lane County Grand Jury of the crimes of

committed as follows:

COUNT I

The defendant on or about the 19th day of May, 1983, in the county aforesaid, did unlawfully and intentionally cause the death of Cheryl Lynn Downs, a human being, by shooting her with a firearm; contrary to statute and against the peace and dignity of the State of Oregon;

COUNT II

and as part of the same act and transaction as set forth in Count I herein, the defendant on or about the 19th day of May, 1983, in the county aforesaid, did unlawfully and intentionally attempt to cause the death of Christie Ann Downs by shooting her with a firearm; contrary to statute and against the peace and dignity of the State of Oregon;

COUNT III

and as part of the same act and transaction as set forth in Count I and Count II herein, the defendant on or about the 19th day of May, 1983, in the county aforesaid, did unlawfully and intentionally attempt to cause the death of Stephen Daniel Downs by shooting him with a firearm; contrary to statute and against the peace and dignity of the State of Oregon;

COUNT IV

and as part of the same act and transaction as set forth in Count I, Count II, and Count III herein, the defendant on or about the 19th day of May, 1983, in the county aforesaid, did unlawfully and intentionally cause serious physical injury to Christie Ann Downs, by means of a firearm, a deadly weapon; contrary to statute and against the peace and dignity of the State of Oregon;

COUNT V

and as part of the same act and transaction as set forth in Count I, Count II, Count III and Count IV herein, the defendant unlawfully and intentionally cause serious physical injury to Stephen Daniel Downs by means of a firearm, a deadly weapon; contrary to statute and against the peace and dignity of the State of Oregon.




